This Prospectus Supplement (the "Supplement") constitutes a supplement to and must be read in conjunction with the Prospectus dated 11<sup>th</sup> November 2009, as supplemented by the supplements thereto dated 9<sup>th</sup> February 2010 and 23<sup>rd</sup> March 2010 (the "Prospectus") prepared by Volvo Treasury AB (publ) (the "Issuer") guaranteed by AB Volvo (publ) (the "Parent") with respect to the U.S.\$ 15,000,000,000 Euro Medium Term Note Programme (the "Programme"). Terms defined in the Prospectus have the same meaning when used in this Supplement.

Application has been made to the Luxembourg *Commission de Surveillance du Secteur Financier* (the "CSSF"), as competent authority for the purposes of the Luxembourg Law on Prospectuses for Securities implementing Directive 2003/71/EC (the "**Prospectus Directive**"), to approve this Supplement.

Each of the Issuer and the Parent accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer and the Parent (each having taken all reasonable care to ensure that such is the case), the information contained in this Supplement is in accordance with the facts and contains no omission likely to affect its import.

This Supplement has been prepared pursuant to Article 16.1 of the Prospectus Directive for the purposes of incorporating by reference the document mentioned below.

The following documents have been filed with the CSSF and by virtue of this Supplement such documents shall be deemed to be incorporated by reference into and form part of the Prospectus:

- The audited annual report of the Issuer for the financial year 2009 ended on 31st December 2009 (the "Issuer's Annual Report 2009");
- The quarterly unaudited interim report of the Parent and the Volvo Group for the three months ended on 31<sup>st</sup> March 2010 (the "Volvo Group Q1 2010")

Copies of this Supplement and the documents incorporated by reference will be available (i) without charge from the specified offices of the paying agents and (ii) on the website of the Luxembourg Stock Exchange (www.bourse.lu).

To the extent that there is any inconsistency between (a) any statement in this Supplement and (b) any other statement in or incorporated in the Prospectus, the statements in (a) above will prevail.

Except as disclosed in the Prospectus (including the documents incorporated by reference) and in this Supplement, there has been:

- (i) no significant change in the financial or trading position of the Issuer since 31st December 2009;
- (ii) no significant change in the financial or trading position of the Parent or the Volvo Group since 31st March 2010; and
- (iii) no material adverse change in the prospects of the Issuer, the Parent or the Volvo Group, in each case, since 31st December 2009.
