Issue of bond loan

Volvo Treasury AB (publ) has decided to issue a SEK 500 million bond loan under its EMTN (Euro Medium Term Note) programme. The bond loan will be issued on March 7th, 2008 with a maturity on September 7th, 2009. The bond loan has a fixed interest rate.
